**6.** <u>18-0466</u> Discussion on the Transportation Demand Management Plan.

Jason Gilman reviewed the draft plan and asked for feedback from the Commission. Comments included:

- -Woodward was excited about the plan and supportive of active commuting. She was also interested in large employer incentives that promote active commuting.
- -Kuhlman noted buildings versus surface parking is beneficial to both the company but also the City.
- -Yager noted we would need to enhance our public transit system if promoting non-single driver commuting. Mayor Kabat noted the transit plan includes more express and circulator routes. Yager inquired if large employers have been surveyed to see if employee interest would be enough to support the ridership needed for additional transit routes.
- -Tischer noted Park and Rides at the edges of town with buses often enough to downtown and large employers could be successful. She also noted that the plan may not be conducive to seniors who have mobility issues.
- -Schoenfeld stressed the importance of enhanced transit systems. He noted a smartphone app would be helpful to see where the buses are on their routes.
- -CM Marshall noted the Park and Rides could be in the outlying municipalities for ease of use.
- -Mayor Kabat noted parking maximums and implementing no parking requirements in certain redevelopment areas.
- -CM Marcou inquired if we worked with the County on developing the plan; Kuhlman noted several County staff served on the ad hoc committee.

Gilman noted commissioners could share additional comments via email or written on a hard copy of the plan.
