Welch is working through capital improvement program proposals and will continue process of narrowing down request. Lokken announced Washburn Garden Expo on 3/2, little free pantry, Cass St. design review (next meeting 3/12 at 4 pm), launch of downtown steering committee, and Burns Park planning. Garland announced citizen-led process to establish multi-use trail in Myrick Park and name of new apartments on Campbell Rd. Manke announced review of campus-neighborhood plan, planning for basketball court placement, and closing of skate for kids for the season. CM Ostrem announced CIP request for paint and fix-up program using TIF. Jacob Sciammas announced La Crosse Neighborhoods, Inc. elections at their next meeting.

- Will awards be given when there isn't a Mayor's expo?
- Can staff explain what the NRC does at the fall all-neighborhoods meeting?
