Woznak reviewed progress on study. Based on responses to survey of July '17 rain event, City may have strong case that FIS over-predicts flood risk. The DNR would likely be supportive of a Letter of Map Revision for the area using calibrated approach. Discharge estimates near Floral Ln need further refinement and remodeling. Area south of Farnam St. would also have to be remapped. Woznak estimates about 52 houses could be removed; \$110,000 total for LOMR process (which includes south of Farnam St.). Committee asked CM Neumeister to include funding in CIP. Lenz suggested specifically asking for a reply from the DNR regarding if this calibration approach be acceptable to move forward to a LOMR.

Janssen made a motion, Becker seconded, to approve this letter with Lenz's suggestions. The motion carried by voice vote.
