Weidenbach requested more information on previously allocated \$33,500 for La Crosse Center art; identified budget item for Dancers relocation (CIP-2019-166); Parker advocated that La Crosse Center art request be broadened to include Indigenous, Hmong, and other minority artists in area; McKnight suggested La Crosse Center funding be used for infrastructure to mount or hang art as well. Staff suggested close collaboration with La Crosse Center Board and administration on art recommendations.
