### **Agenda Items:**

#### ISG Presentation of New Concepts

Will Kratt and Kevin Bills of ISG presented the most recent concepts as possible considerations for the La Crosse Center Board. The concepts all have a 4 step process......1) selection of a base concept 2) decisions on good - better - best amenities, finishes, square footage 3) "Bolt on" or "add on alternatives" 4) stretching spaces as parameters allow.

All concepts taking into 3 major parameters a) do not go into the park b) stay within the \$42 million budget 3) do not infringe on the Pearl Street walkway.

Concept 1 is the North Concept.....9,500 square foot ballroom, atrium, potential double stack of meeting rooms, prefunction area, connector on the East side of the venue, outdoor balcony.

Concept 2 is the South Concept.....because the South Concept would require the acquisition of the Radisson Center which the City currently does not own...this concept is not being further developed at this time.

Concept 3 is the West Concept.....12,000 square foot ballroom, atrium, larger breakout rooms, larger prefunction area, an 8,000 square foot north hall, east side connector, outdoor plaza area, with an add on of a west side connector to the southern part of the venue.

1st Public meeting on November 28, 2018.

Questions of main difference between the concepts were asked, permits and approvals, bonding/financing options, use days and financial forecasting of the north hall, reduction of deferred maintenance if building new, can add ons/bolt ons be added in phases, economic impact, seating capacities, staffing needs in the future were many of the question asked.
