WisDOT is currently studying different barrier options to separate bicycles/pedestrian from cars. They would like a preferred option to be suggested by the City of La Crosse for further consideration by Minnesota DOT in addition to Wisconsin DOT. More research is needed before a barrier recommendation can be made. In the short term the focus will be on the expansion of the existing sidewalk to 10 foot multi-use paths from the Cameron/ Cass bridges to the West Channel bridge.
