<u>19-1449</u> DOT Transportation Alternative Program Application

Three projects were offered by the BPAC for possible TAP application; Avon St. Greenway, Wagon Wheel Connector, and 2nd St. Francis Schelfhout suggested that projects less than \$300,000 could be feasible, this is a change from past DOT policy. All applications should avoid the use of eminent domain to acquire property. Matt Gallager suggested that design costs be added to total project costs
