He added that the project could qualify for a TAP or MLS project. Gallager said Farnam Bike Blvd could be a good candidate for a design planning and staff could begin outreach to neighborhood.

Melby suggested showing which racks were on camera in downtown cameras. Sleznikow suggested posting notification that a bike rack is under surveillance. Carolyn Dvorak said students had been noting hazardous conditions and traffic; data would have to be compiled in GIS. Young suggested a place to submit hazards in the StoryMap.

The next meeting date is 12/10. Possible agenda items include review of WisDOT plans for La Crosse St. redesign, decorative crosswalk policy, Rivercrest Village easement, getting routes signed, and infrastructure improvement for bike share system.
