-2020 has been a strong year for fishing. Currently promoting "safe leisure travel." La Crosse is currently ahead of the curve for occupancy. Staff members furloughed during initial months of the pandemic but are now starting to return and working on bookings for three to four years from now.

-In 2021, numbers are conservative as hesitation is still expected, but hopeful for the second half of the year. Mr. Frels hopes to have Beer, Wine, and Cheese festival and trolley operation. Ads for the Visitors guide in 2020 will be honored in the 2021 guide at no cost.
