The Commission discussed direction, vision, and next steps for educational opportunities. No action was taken on this item.

Turner explained the educational opportunities are to be centered around the Human Rights Commission, what they are doing for the City, and educate the public about opportunities and resources the Commission provides.

McDermid suggested providing a workshop for employers in the community centered around providing a more include workspace. She also suggested a tiered level, multiple training sessions with the topic of anti-bias; how do we change that at the next level; and the level after that could be business sharing with one another what they are individually doing regarding anti-bias.

Maye-Cates suggest that to see tangible results: the current list of city leaders should be expanded, narrow the focus for outreach, and provide a framework. As well as, use an approach that incorporates the language of diversity and inclusion.

Council Member Christians provided context that a lot of local businesses has already done a lot regarding these topics, and we can learn from them and best efforts.

Caroline Gregerson suggested a roundtable of local businesses, talking about what they are doing and what they could do more of.
