## **Temporary Street Privilege Permit Factsheet**


- When is permit needed
  - Use of streets, alleys, sidewalks, or other public ways or places of the city for purpose of impeding from construction, reconstruction, maintenance, repair or demolition
- Cost
  - First five days \$35
  - \$2 for each additional day
- Condition of occupancy
  - Obstruction less than 1/3 of street or alley
  - Sufficiently lighted at night
  - o Sidewalk traffic not interrupted
  - o Continuous construction or demolition
- Cash deposit
  - o Deposit required if city-owned facilities to be moved or replaced
- Insurance
  - Required public liability insurance no less than \$100,000 each person, \$300,000 each accident for bodily injury and \$100,000 for property damage
  - The insurance required shall be written by insurance companies who are rated "B" or better in Best's Key Rating Guide and shall be licensed to do business in the state of Wisconsin.
  - The Certificate of Insurance MUST name the City of La Crosse as Additional Insured.
- Bonds
  - Damage likely to streets, alley, sidewalk, or other property will required a bond


