AN ORDINANCE to amend Secs. 10-588 and 10-589 removing pedal cabs from Public Vehicles for Hire and to create Sec. 2-2(b)(24) and Article XVIII in Chapter 10 of the Code of Ordinances of the City of La Crosse regulating pedicabs and pedal cars.  
Please take notice that the above Ordinance was adopted by the Common Council of the City of La Crosse on September 10, 2015. A summary of the subject matter and main points of the ordinance is as follows.  
• Establishes regulations and license requirements for pedicabs and pedal cars  
• Provides restrictions for waiting area, loading and unloading  
• Provides requirements for drivers, and operator's license  
• Provides requirements for vehicle markings, safety and maintenance  
• Prohibits glassware, loud music and alcoholic beverages  
• Establishes operating hours  
• Establishes revocation, suspension and appeal process
