2. <u>15-0704</u> Application of Jeffrey Skarboszewski for a Conditional Use Permit at 2036 George Street to allow a fence greater than 6 feet in height.

Richard Becker moved to refer the item for 90 days and direct staff to research tall fence ordinances from other cities and work with the Inspections Department to determine if the fence can be attached to the house and if the adjacent business is operating within its legal confines. James Cherf seconded. The motion passed 6-0.

3. 15-0746 Request of Maria Norberg dba Grounded Coffee LLC (Apothik) for extension of Conditional Use Permit allowing her permission to apply for a Combination "Class B" Beer & Liquor license at 304-308 Main Street and resolution approving same.

Richard Becker moved to extend the Conditional Use Permit until January 4, 2016 to allow for application for a Class "B" Beer & Liquor License for the February 2016 cycle. James Cherf seconded. The motion passed 6-0.

4. <u>15-0774</u> Review Sign Plans for Agropur Ingredients located at 2340 Enterprise Avenue.

James Cherf moved to approve the sign plans with the condition that landscaping, such as flowers, shrubs, or other plantings are installed around the base of the proposed monument sign and that the monument sign is located outside of the required vision clearance. Scott Neumeister seconded. The motion passed 6-0.

Review plans for exterior HVAC modifications for Inland Printing located at 3209 Airport Road.

Richard Becker moved to approve the plans as submitted. James Cherf seconded. The motion passed 6-0.
