AN ORDINANCE to create paragraph 11.03(B) (7) of the Code of Ordinances of the City of La Crosse creating a Slow No Wake Zone in Bluff Slough within the City Limits of the City of La Crosse.

THE COMMON COUNCIL of the City of La Crosse do ordain as fol-

lows:
SECTION I: Paragraph 11.03(B) (7) is hereby created to read as follows:
(7) There shall be a slow no-wake zone in that part of the waterway known as Bluff Slough, which is a backwater of the Mississippi River, located in the City of La Crosse and the Town of Shelby, legally described as: All that part of the SW1/4 of the SE1/4 of Section 8, City of La Crosse, and that part of the NW1/4 of the NE1/4 of Section 17, Town of Shelby; and that part of the NE1/4 of Section 17, City of La Shelby; and that part of the NE1/4 of the NE1/4 of Section 17. City of La Crosse, all in Township 15 North, Range 7 West described as follows: Commencing at the northeast corner of said NW1/4 of the NE1/4; thence South along the east line thereof, being also the boundary between the City of La Crosse and the Town of Shelby 532 feet to the point of beginning; thence Northeasterly 200 feet to the southeast corner of Lot 17, Huber Hornes, which is on the lot line between 2808-2810 and 2816-2818 Huber Court; thence Northeasterly along the easterly shore line of Bluff Huber Court; thence Northeasterry along the easterly shore line of Bluff Slough (also known as Swift Creek or Running Slough) 2,025 feet more or less to a point 233 feet south of the north line of said SW1/4 of the SE1/4 of Section 8, said SW1/4 of the SE1/4 of Section 8, said point being the southwest corner of 2514 Riverside Drive; thence Southwesterly at a right angle to the shore line 325 feet to the westerly shore line of Bluff Slough; thence Southeasterly along the westerly shore line of Bluff Slough; a distance of 2 100 feet more of each tendence of 2 100 feet more of each tendence of 2 100 feet more of the stance of 2 100 feet more of 2 100 f tance of 2,100 feet more or less to
