We talked about it and figured the 1820 Onalaska Ave house would be too small for a family of five, so we talked to the renters and they wanted to stay. They signed a new lease through June 2015.

We are currently renting right now and trying to buy another house that will fit a family of five. My wife is due in May so we are kind of in a time crunch. I don't want any trouble with this and am willing to pay any fees I need to make this right. If you could waive 8.07 (I) it would be greatly appreciated. Thank you for your time.
