# Curbside Pick Up of Wine, Beer, and Spirits Department

### Placing the order:

Orders will be placed on-line through People's Food Co-op's Curbside Pick Up site.

Online grocery orders will be paid and processed in a separate transaction before the customer arrives at the store.

Beer, Wine, and Spirits Department orders will be paid at the time of pick up using a handheld device. After adding a Wine, Beer, and Spirits order, customers will be asked the following questions: Name, DOB, Photo ID Type/#/exp. Date, car type (make/model), License plate #.

#### Pick up, verification, and payment:

Wine, Beer, and Spirits payment and delivery will take place at the customers car in one of the two designated Curbside parking spaces located in the People's Food Co-op Parking Lot.

## At the designated time of pick up, a licensed beverage operator will:

- Bring the order out to the car
- check the photo ID
- verify the customer information entered at time of purchase through the Google Form (name, age, photo ld type/#/exp, car type, license plate #)
- take a picture of the vehicle with the license plate
- accept payment from the customer via handheld card reader with a Square App.
- Load product into the car
- Staple detailed register receipt with detailed description of Wine, Beer, and Spirits order will be stapled directly to the order sheet
- If the person who placed and is picking up the order is not the driver of the vehicle. The driver of the vehicle will also be carded and if they are not at least 21 years of age, the sale will be denied.
- If the driver of the vehicle is underage or appears intoxicated, the sale will be denied, and police will be notified.

Documentation will be saved for at least 30 days.

People's Food Co-op Curbside Pick Up is not same day service (currently next day or the day after)- orders will not be filled until at least one day after they are placed.

Curbside Pick Up for alcohol will only be allowed between the hours of 9 am and 6 pm.
