CERTIFICATE OF INDEBTEDNESS

Chapter 24 of the Wisconsin Statutes authorizes the Board of Commissioners of Public Lands to invest State Trust Funds in loans to municipalities. The municipalities are empowered to borrow from the Trust Funds in accordance with the provisions of Chapter 24 and this certificate of indebtedness.

The City of La Crosse in the County(ies) of La Crosse did on February 21, 2022, apply for a Trust Fund Loan from the Board of Commissioners of Public Lands in the amount of Four Hundred Seventy Thousand Two Hundred And 00/100 Dollars (\$470,200.00), together with interest thereon at the rate of 2.50 percent per annum, payable in annual installments. The term of the loan is for 5 years.

The Mayor and Clerk of the municipality have been authorized to execute and deliver to the Board, the necessary Certificates of Indebtedness for the sums owing according to the terms of the loan agreement, all in conformity with Chapter 24 of the Wisconsin Statutes.

This Certificate of Indebtedness is issued pursuant to and in conformity with Chapter 24 of the Wisconsin Statutes.

The City of La Crosse in the County(ies) of La Crosse acknowledges that it is indebted to the State of Wisconsin Board of Commissioners of Public Lands in the amount of Four Hundred Seventy Thousand Two Hundred And 00/100 Dollars (\$470,200.00) together with the interest thereon at the rate of 2.50 percent per annum, to be repaid as provided in the application for the loan, the payment schedule and Chapter 24, payable in annual installments on March 15 of each year with the first payment due on March 15, 2023 and the final payment due March 15, 2027.

Any prepayments must be made after January 1 and prior to September 1 of each year. It is agreed that in the event of such prepayment, thirty days written notice of the prepayment must be given to the Board of Commissioners of Public Lands and that any additional payment or prepayment must be sent to the Board of Commissioners of Public Lands Office.

Annual payments will be made payable to the Board of Commissioners of Public Lands as indicated on the annual billing statement.

The undersigned acknowledge that should the Borrower default on this loan, the Board of Commissioners of Public Lands may use any remedies available under the law and is required under Wisconsin Statute Section 24.70(6) to intercept any state payments that may be otherwise due the Borrower.
