AN ORDINANCE to create Section 2.37(A)(6) and to amend Subsection 2.37(B) and (C) Of the Code of Ordinances of the City of La Crosse regarding mobs or riots - emergency action.

AN AMENDED ORDINANCE to create Paragraph 15.04(N)(3)(vi) of the Code of Ordinances of the City of La Crosse regarding existing fences adjacent to or encroaching into alley right of way.

Motion by Becker, seconded by Cherf, to amend changing the word "Existing" to "All". The motion carried unanimously on voice vote. On motion that this Ordinance be RECOMMENDED TO BE ADOPTED AS AMENDED to the Common Council, due back by 3/13/2014. The motion carried unanimously by voice vote.

14-0165

AN ORDINANCE to repeal a portion of Section 25.01 of the Code of Ordinances of the City of La Crosse to rescind the permit and fee requirements for roofing, siding and window replacements.

Motion by Becker, seconded by Cherf, to amend with proposed resolution to retroactively take effect on November 27, 2011 and allow application for refund. The motion failed 2-13 (Cherf and Becker voted no, Jerome abstained).

Motion by Johnson, seconded by Jerome, to divide the question taking roofing permits separate from windows and siding permits. The motion passed 9-7 (Richmond, Cherf, Seaquist, Becker, Formanek, Medinger, Swantz voted no).

Before voting, Chair Seaquist clarified a "yes" vote would eliminate fees, a "no" vote would keep fees.

On roofing permits and fees, the motion failed to eliminate fees 6-10 (Richmond, Miller, Johnson, Becker, Formanek voted yes).

On windows and siding permits and fees, the motion carried to eliminate fees 10-6 (Svitavsky, Seaquist, Kader, Formanek, Happel, Swantz voted no).

Motion by Kader, seconded by Kader, to refer to budget committee. The motion failed 4-12 (Svitavsky, Kader, Sullivan, Swantz voted yes).
