Andrea Schnick reviewed the ordinance signed in 2013. She noted why this ordinance should be reviewed and updated, noting specifically the recommendation to change 10% of the project cost to 10% of the increased assessed value on page 9 of the TIF application. Commissioners noted on page 2 the terms of office could be changed. The commission was supportive of the proposed changes and asked staff to bring documents to the next meeting to vote.

2. Consideration of DuraTech TIF application

Andrea Schnick introduced Doug LaFleur and Pete Johnson from Duratech. Doug and Pete outlined their plan for building expansion. Andrea will be reviewing the Ehlers report and will prepare a staff report for next month.

3. Consideration of La Crosse Plow Building TIF application

A small working group of EDC members and staff have been communicating with the Clearys on their TIF application. They will arrange an additional meeting with the applicant before the February meeting.

4. Update on Buzz's Bike Shop (showings, tax credit status)

Andrea Schnick provided an update on the building. No historic tax credits are available at this time, as the application has been denied twice. Staff has shown the building to prospective tenants several times; some uses included an artist space, commercial space, catering space or reopen Buzz's Bikes with a different owner. Andrea will review a need for an elevator. Andrea has inquired with HSR about redoing the outdated A&E analysis, but the cost is \$5000 so has not been completed. Andrea will investigate options to take down the 802 portion of the building. The City has invested about \$320,000 into the property. Andrea will check what the current assessment is. She noted DeBoer was needed to clean up dead pigeons. Andrea will also investigate what it would take to have the building removed from the Local Register of Historic Places.

5. TID 13 Amendment Update

Andrea Schnick provided an update. The Joint Review Board finalized the TID 13 amendment, noting that the City Plan Commission added some verbiage on page 17 of the Project Plan allowing for more flexibility.
