Description:

I have good reason to believe that Dale (property manager) at Wedgewood Commons has been stirring up pestering with me and other state mental health cases living in and around the building where I live. I also believe that a social worker by the name of Wilson has been stirring up pestering with me and men and women who are state mental health cases. All with no basis!!! I have made 2 written complaints about this to the Tenant/Landlord Resource Center in LaCrosse. I think Dale and this Wilson woman have been making pestering calls about me and other residents to law enforcement. These 2 women have no respect for anyones privacy with what I have been seeing. I cant stand this quezziness in the stomach that I have been dealing with! They will not stop speaking with disrespect towards me! This has been going on for almost 3 years now!! I dont know any residents where I live. I am staying away from them because I saw what some black woman said to Dale about me and to this Wilson woman. I only spoke to this black woman one time almost 3 years ago when I moved in to this complex. Dale is not to be playing around with social workers. It is not in the lease agreement! I have a right to my privacy. I want these two sick ladies down. They stand with their backs turned against me and other residents! Get them down!! Please!! I saw all this in my medical file at Gundersen/LaCrosse!)

I saw suspicious activity with State Bank downtown in November and December, I am seeing suspicious activity with Altra Credit Union on Losey Blvd as of this month. Have Dan Mitley, Jim Dunnum (PI's), and a social worker by the name of Wilson been stirring up pestering with me and the staff at both locations? I also think that my privacy has been invaded with the internet at home. Wedgewood Commons pushes notices to me and other residents over the internet. I wonder if the office staff got my routing number with Altra Credit Union, I am seeing as of the this week an amount of money with Altra that is lower than it should be. I am going to Altra this week to see what is happening with my account. Please get these filthy tongue wagging people down from this city!! These people have no respect for the law from what I have been seeing!! I inherited some money from two family members and the staff at human Services knows what is going on with me regarding this!!
