AN AGREEMENT DESIGNATING THE
SECRETARY OF TRANSPORTATION AS ITS AGENT

WHEREAS, the City of La Crosse, La Crosse County, Wisconsin, hereinafter referred to as the Sponsor, desires to sponsor an airport development project to be constructed with federal aid and/or state aid, specifically, the La Crosse Regional Airport project to:

Purchase New Passenger Boarding Bridge, Rehabilitate Existing Boarding Bridges, Replace Perimeter Fencing and Gates, Purchase Mowing Equipment, Runway 13/31 Rehabilitation, Construct East Hangar Development Area, Reconstruct Terminal Service/Loading Lot; and any necessary related work.

WHEREAS, the Sponsor adopted a resolution on April 9, 2015 a copy of which is attached and the prescribed terms and conditions of which are fully incorporated into this agreement, designating the Secretary as its agent and requesting the Secretary to act as such as set forth in the resolution; and

WHEREAS, upon such request, the Secretary is authorized by law to act as agent for the Sponsor until financial closing of this project;

NOW THEREFORE, the Sponsor and the Secretary do mutually agree that the Secretary shall act as the Sponsor's agent in the matter of the airport development as provided by law and as set forth in the referenced resolution; provided, however, that the Secretary is not required to provide legal services to the Sponsor;
