

Forest Avenue and 13th Street Vacation

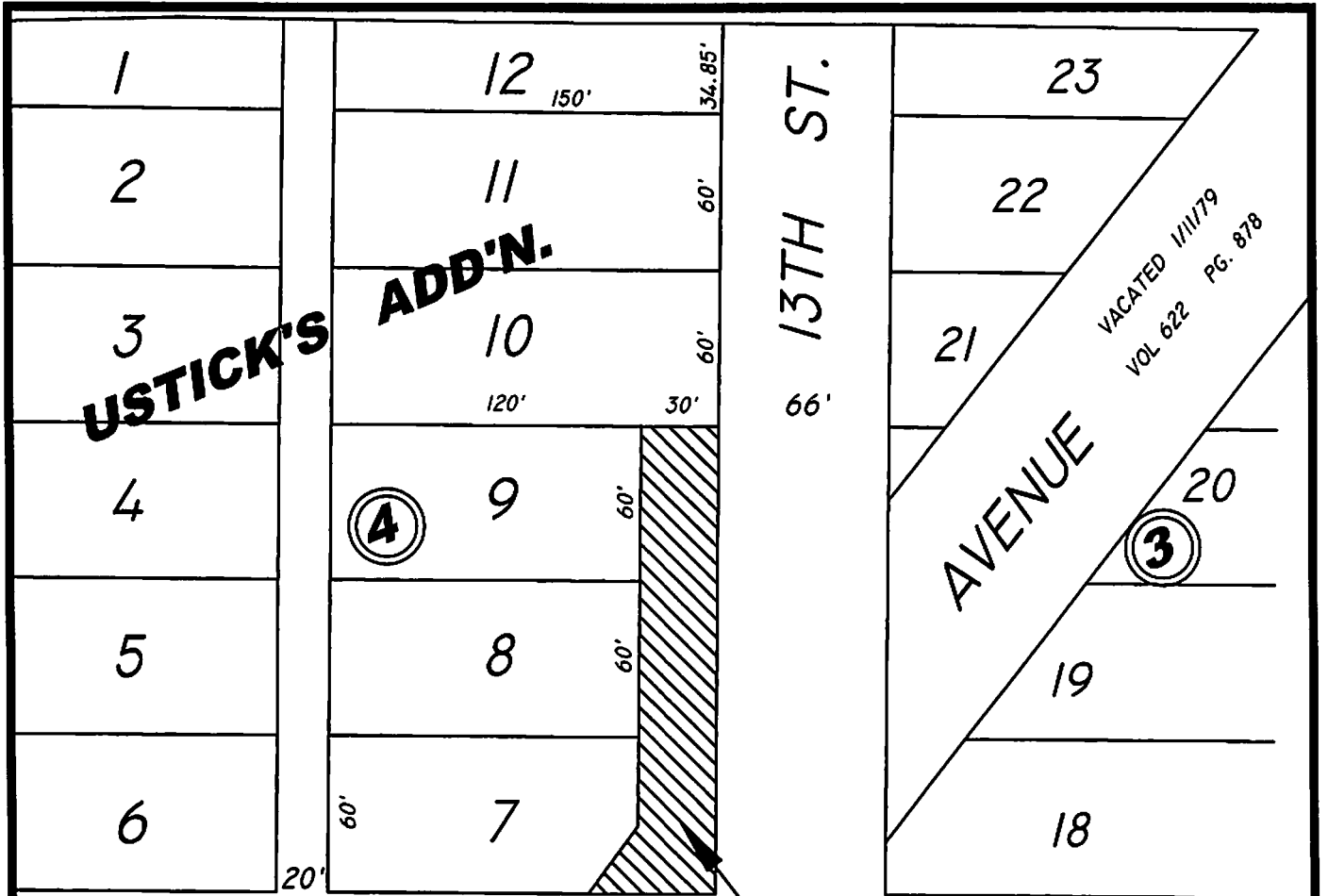
