➤ **RECOMMENDATION OF OTHER BOARDS AND COMMISSIONS:**

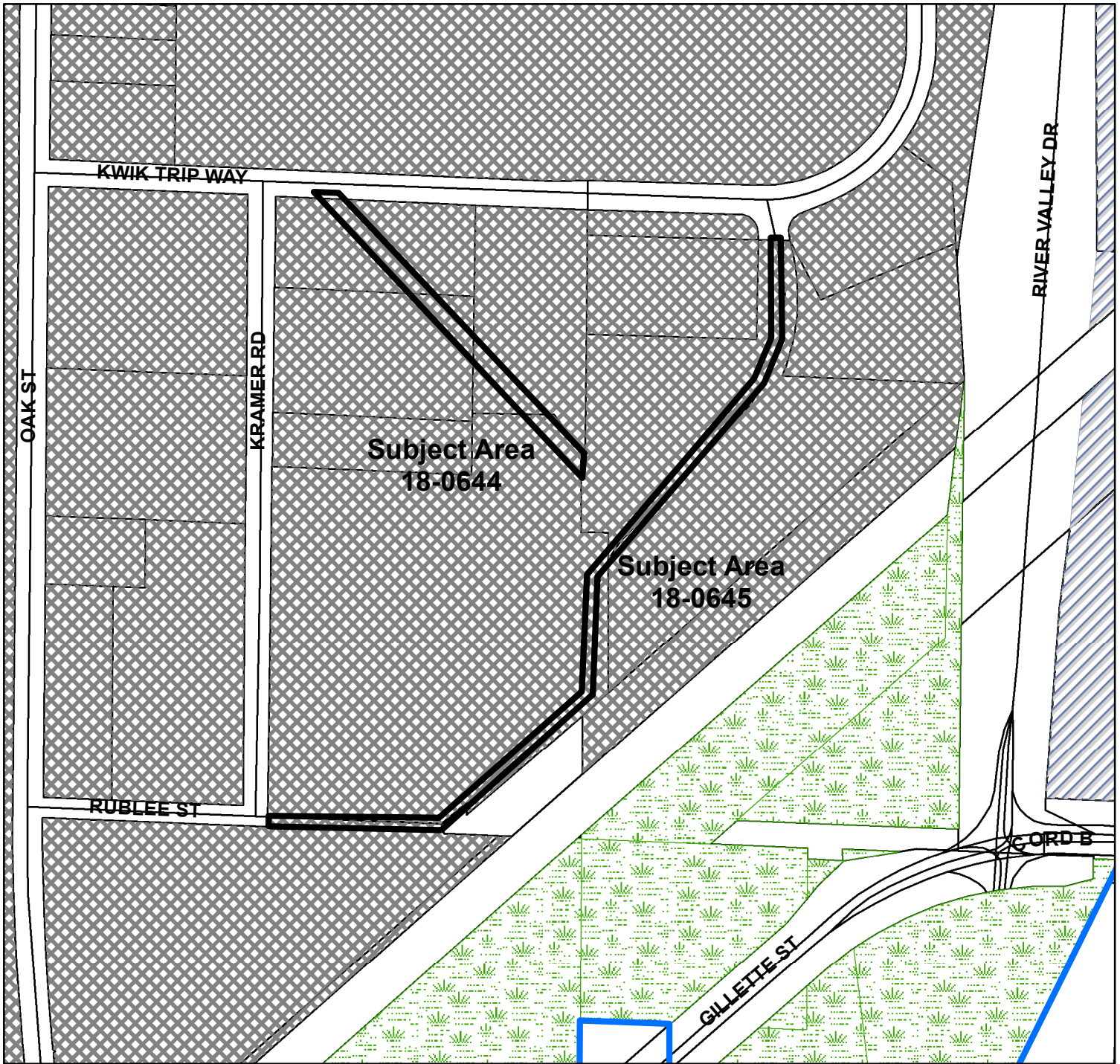

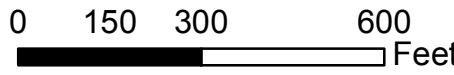

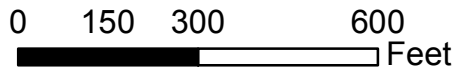
