I hereby submit, for your consideration, an offer to purchase 305 square feet of city-owned property that has an estimated market value of \$3.51/sq. ft.

As previously reported, Trueline acquired the former Jacobson Moving building (612 2nd St. S.) in the fall of 2012 with the intent of expanding manufacturing. This expansion will increase employment opportunities and expand Trueline's manufacturing into plastics. In order to fully utilize the building, a 3-story addition with an elevator and stair tower will be required by code. The existing building does not have access to upper floors, as the twin building that was torn down held the access to upper floors. On the northwest corner of the existing building, the City's property line returns south (see attached certified survey).

The sale of this property to Trueline will allow us to build a code-compliant stair tower to access and use the upper floors of our building. The location and condition of this building are not easily adaptable for residential or office space, and it is already zoned for heavy industrial. Plans for renovating the existing building total more than a \$1 million investment in construction, in addition to significant equipment installations.

I appreciate the opportunity to expand our business in the city of La Crosse. I look forward to hearing from you soon about this purchase offer.

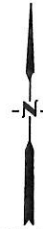

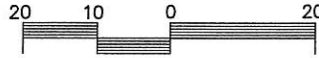

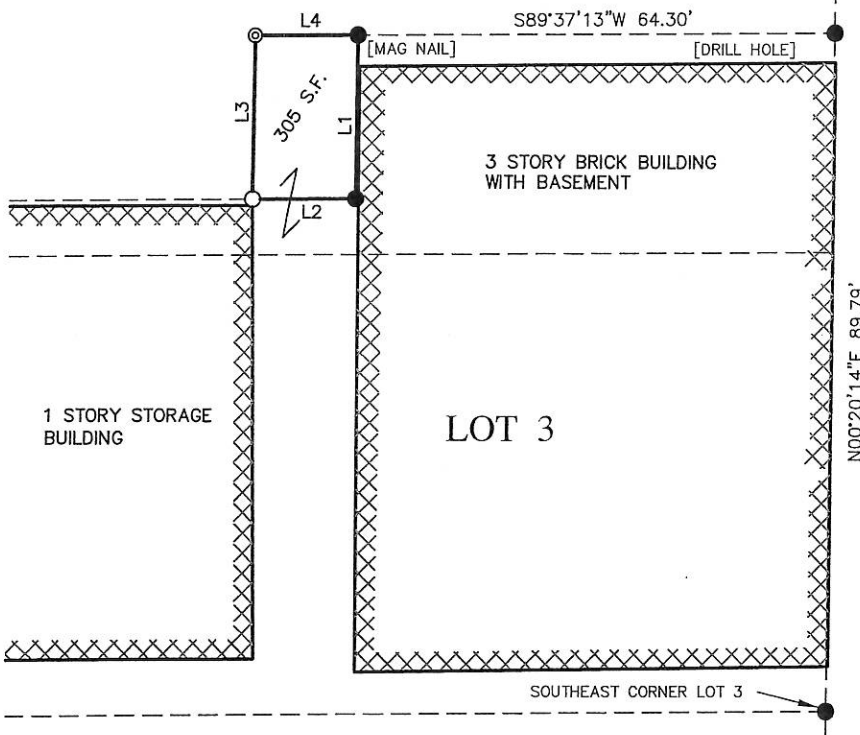
