

Dairyland Power Cooperative is informing the City of La Crosse it has recently concluded its helicopter operations at the La Crosse Regional Airport. Pursuant to Paragraph 8 of the Airport Lease dated July 11, 2001, Dairyland is notifying the City of La Crosse it has identified Tru Gas of Florida, Inc. as a potential sublesor of Dairyland's airport hangar. Dairyland and Tru Gas of Florida are requesting the City of La Crosse grant permission to allow Dairyland the ability to assign the Airport Lease to Tru Gas of Florida, and assume the conditions of the abovementioned Airport Lease for its remaining term. Tru Gas of Florida has presented a copy of its Certificate of Airworthiness and a Certificate of Insurance to Dairyland for the aircraft they wish to store in the hangar, both of which are enclosed with this letter.
