Such public hearing will be held at 7:30 p.m. on Tuesday, November 4, 2014 in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
The City Plan Commission of the City of La Crosse will meet to consider such ordinance on Monday, November 3, 2014 at 4:00 p.m. in the 3rd Floor Conference Room in City Hall and final action will be determined by the Common Council on Thursday, November 13, 2014 at 7:30 p.m., both in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
Any person interested may be heard for or against such proposed change, and may appear in person, by attorney or may file a formal objection, which objection forms are available in the Office of the City Clerk.
Such proposed change set forth in the ordinance now pending before the Common Council of the City of La Crosse is as follows:
AN ORDINANCE to create Subsection Section 115-343(17) of the Code of Ordinances of the City of La Crosse allowing residential on the ground floor in the Community Business zoning district by a Conditional Use Permit.
