Below are comments regarding the proposed CSM.

1. Please correct the distances on both north/south parcel boundary lines.
2. Please show the centerlines of all proposed streets.
3. Please include the dimensions of all proposed streets on each side of the centerline.
4. Please illustrate the Mississippi River.
5. Please illustrate Isle Le Plume Slough.
6. Please remove any line work depicting 40 lines as they are not relevant to Gov't Lot 5.
7. Please verify that WIS Stats authorizes a roadway width of 30' on Marco Drive.
8. Please verify the area of the right-of-way to be dedicated.
9. Please remove La Crosse County from the last sentence of the overall surveyor's certificate.
10. Please consider adding the wording "of this description" at the end of the sentence stating that "Includes land between the meander line and the edge of water."
11. Please consider labeling in bold letters "CERTIFIED SURVEY MAP" on sheets 1 through 3.
12. Please consider showing the additional buildings and lagoons located on the parcel.
