- 4. Authority to sign. The person signing this First Amendment on behalf of Lessee certifies and attests that its respective Article of Organization, Articles of Incorporation, By Laws, member's Agreement, Charter, Partnership Agreement, Corporate or other resolutions and/or other related documents to give full and complete authority to bind the Lessee, on whose behalf of the person is executing this First Amendment. Lessee assumes full responsibility and holds the Lessor harmless for any and all payments made or any other actions taken by the Lessor in reliance upon the above representation.

Further, Lessee agrees to indemnify the Lessor against any and all claims, demands, losses, costs, damages or expenses suffered or incurred by the Lessor resulting from or arising out of any such payment or other action, including reasonable attorney fees and legal expenses.
