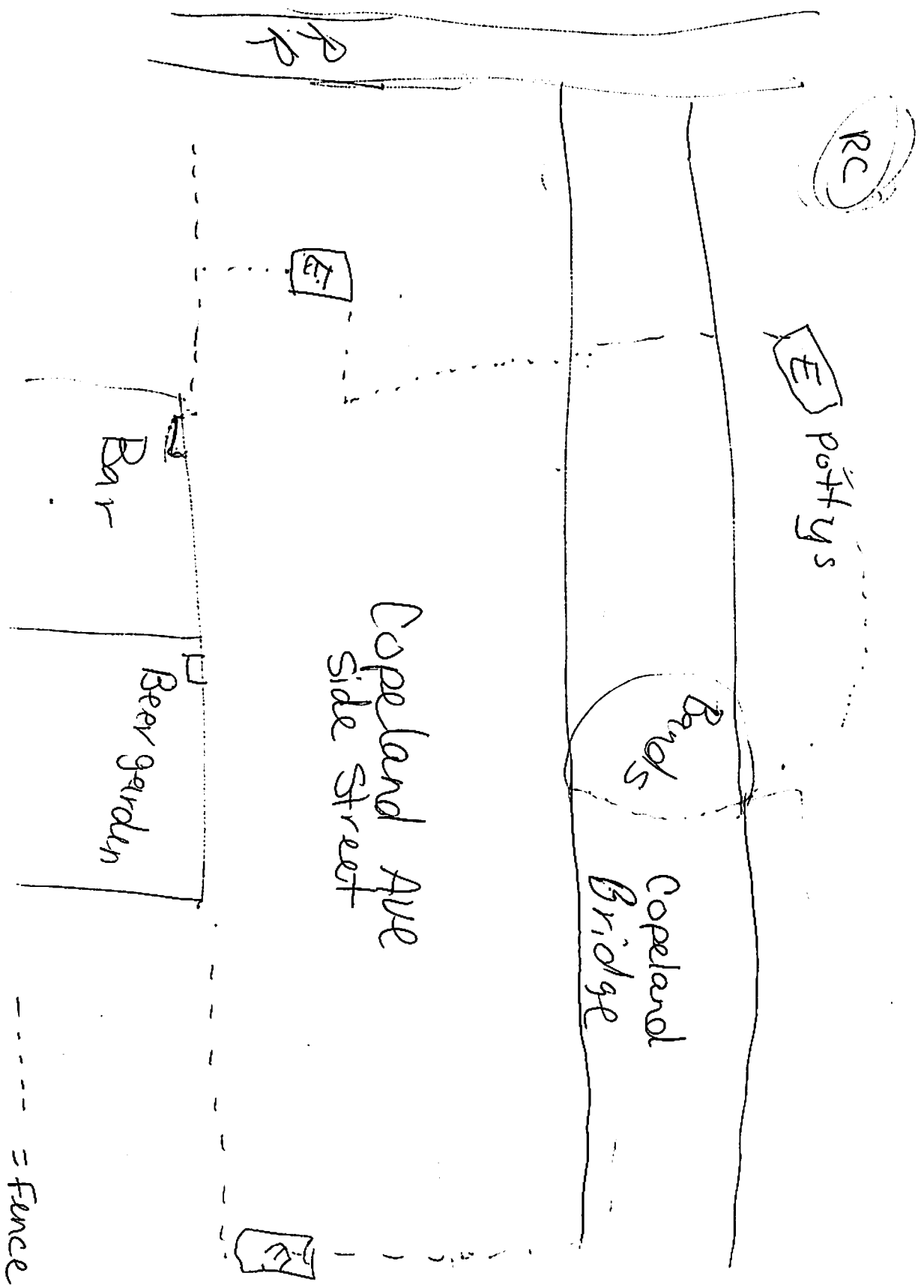

X 500 Copeland = A&S Foster LLC (I think that's you)

506 Copeland = James Danielson, 2610 Van Loon Rd., LaX

X 510 Copeland = Guzman Properties LLC, same mailing address

X 512 Copeland = 530 Copeland = The Board Store, same mailing address (county database shows this property as 512 while post office shows address as 530)
