NOTICE OF ORDINANCE NO. 8270 AN AMENDED ORDINANCE to amend Chapter 115 of the Code of Ordinances for the City of La Crosse regarding bed and breakfasts. Please take notice that the above Ordinance was adopted by the Common Council of the City of La Crosse on December 14, 2023. A summary of the subject matter and main points of the ordinance is as follows.  
• Sec. 115-1 amended definition of bed and breakfast establishment.  
• Sec. 115-149(c)(5) removed bed and breakfast from lot area per family regulations.  
• The following sections were repealed: 115-343(b), 115-355.  
• The following sections were created: 115-142(a), 115-143(a), 115-144(a), 115-145(a), 115-157(a) regarding Bed and breakfast Inns meeting the requirements in Sec. 115-404.  
• Created Sec. 115-404 regarding Bed and Breakfast Inns and requirements.
