Addressed to all City Council Members regarding changing of the city ordinance for public vehicle for hire.

I have owned and operated a taxi company in La Crosse since 2002. My concerns regarding changing the ordinance are as follows:

Item C 1; No vehicle should be more than 10 years old.

If all of the ordinances are followed regarding inspections, safety, maintenance, appearance, etc., the age of the vehicle should not matter. With as many miles as these vehicles get, their life span is much shorter and to constantly replace them with newer vehicles is very expensive and unreasonable.

Item G1; Increase in insurance and additional insured.

Reference has been made to using other municipalities as a model for these changes. I have not found one city in our state or neighboring communities that requires 5 million dollars in insurance. Madison, Green Bay, Eau Claire and Rochester which all have populations much greater than ours, do not have this requirement and the cost of their fares are still double what they are in La Crosse.

I think the increase in insurance is out of line. Since 2002 my total amount of insurance claims \$62,000. The insurance premium per year would be more than \$55,000.

If our insurance premiums more than double, then the cost of a taxi would have to dramatically increase. Many of our customers are non-profit that provide this service to the community, such as the School District of La Crosse, Salvation Army and Safe Ride Program. The majority of our customers that go to and from work, elderly, disabled or on fixed income could not afford this. One of city council members stated that it is a very noble thing to do and that appearance was more important than anything. Our customers highly disagree. Over a three day period we discussed this matter with our customers.

This is only a small portion of the people we serve and nearly everyone was against the changes proposed. Attached is list of just a few of our customers and community members who are opposed to these changes and feel it would cause hardship.

Item H3; Schedule of Rates.

The ordinance states it shall be unlawful for any owner or operator to charge or permit to be charged any other or different rates of fares then those listed on such schedule.

This is not new, however, it has over the last decade become so frustrating to watch hotels, bars, and restaurants dramatically raise their prices during peek activities, but taxi's are not allowed to. Delivery drivers, tow trucks and refuse drivers can all add a surcharge to their service when fuel goes up but we are not allowed to. This needs to change.

Over the years, the requirement to follow the ordinance or the law have been ignored. More emphasis needs to be put on monitoring the people that are taking advantage of the visitors, elderly or intoxicated people and outright break the law.

I believe that these ordinances would put a great financial burden on the vehicle for hire service in La Crosse, some of which will just not be able to continue. The community will suffer but not more than the residents that rely on this service on a daily basis.
