

REPRESENTATIONS ON THE FACE OF THE MAP

The exterior boundaries of the land surveyed are shown by lines in red, and their dimensions are in red. All interior subdivisions, with their dimensions, are shown in black. Concrete monuments are placed as shown by circles of their respective corners. Fine stakes are placed at all lot corners.

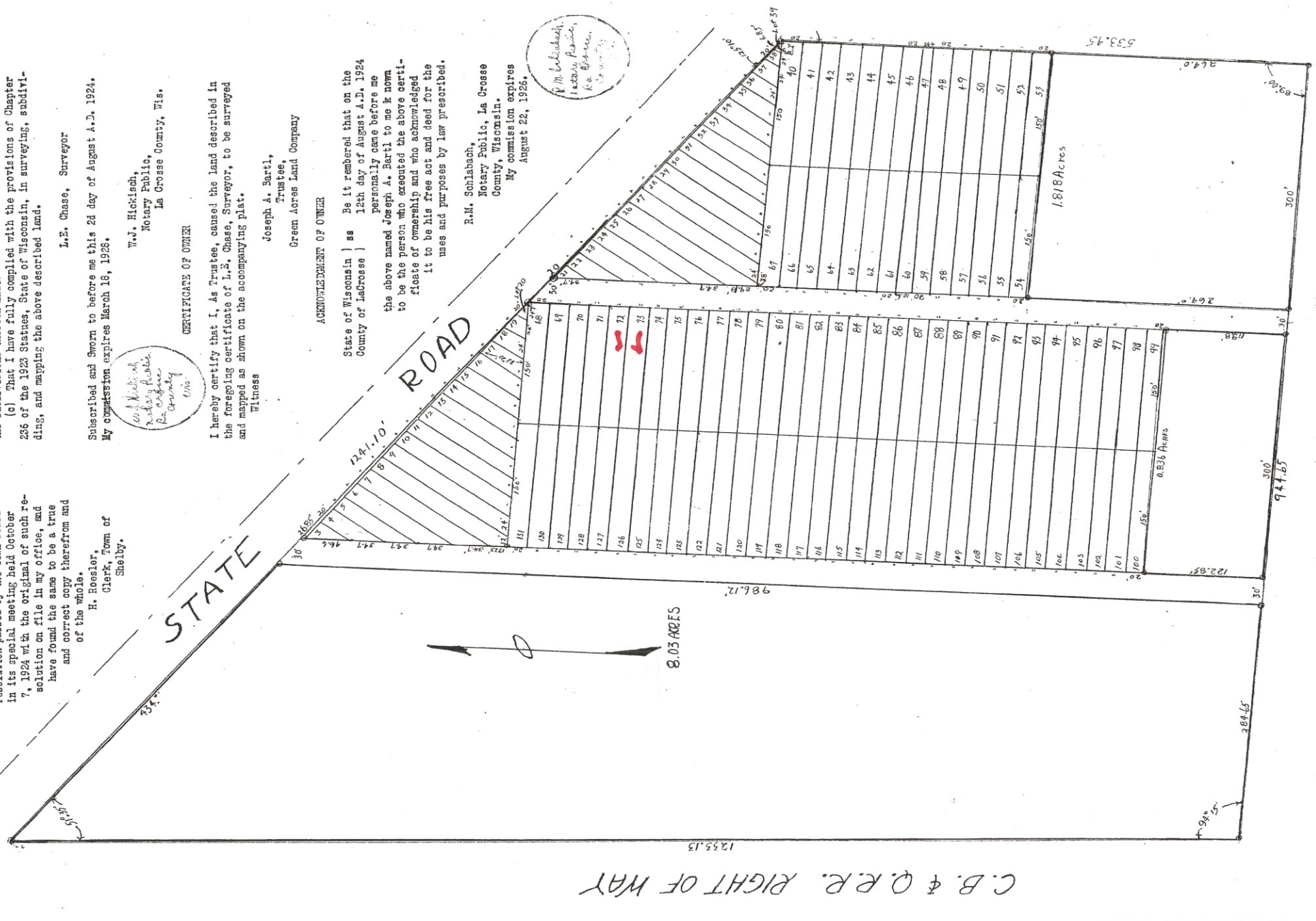
