Such public hearing will be held at 7:30 p.m. on Tuesday, September 2, 2014 in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
The City Plan Commission of the City of La Crosse will meet to consider such ordinance on Tuesday, September 2, 2014 at 4:00 p.m. in the 3rd Floor Conference Room in City Hall and final action will be determined by the Common Council on Thursday, September 11, 2014 at 7:30 p.m., both in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.

Such proposed change set forth in the ordinance now pending before the Common Council of the City of La Crosse is as follows:
AN ORDINANCE to amend Section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Commercial District to the Special Multiple Residence District allowing for a residential duplex.

Proposed Rezoning is Necessary Because: It is not permissible for there to be a residential use on the ground floor of a building zoned Commercial.
