The Committee moved to make the following changes to the nine recommendations for 2014 Capital Improvement Program funding projects:

- Approved repainting of bicycle lanes and arrows
- Removed giving Clinton Street a road diet, because it has Safe Routes to School funding in 2015; any additional funding needed for Avon Street to Ranger Drive
- Approved as amended installing RRFBs at La Crosse Street at Myrick Park Lane; there is not enough room for RRFBs, so the BPAC recommends painting crosswalks on the east and west sides and adding signs

- Approved planning for bicycle boulevards
- Approved as amended giving Monitor Street a road diet; the BPAC recommends adding a curb cut to and from the marsh trail and consider a median protecting left turns
- Removed painting a crosswalk on County Road B at Smith Valley Road; there is not a sidewalk on the other side of the street
- Approved as amended building sidewalks on 33rd Street; the BPAC recommended completing sidewalks from Peace Street to Solaris Lane and do an engineering study to put sidewalks in to Broadview Place
- Approved installing RRFBs on West Avenue at Pine Street; traffic signal removal requires Common Council approval
- Approved painting bicycle lanes on Farnham Street from Losey Boulevard to 31st Place; two full bicycle lanes would require removing the parking lane on the south side of the street
