Notices and Discussions

Katye Sargent introduced herself and provided a review of the Racial Equity Team's meeting. There are 14 members now with a new chairperson and vice chairperson. They are researching plans from other communities and reviewing the municipal code for equity considerations.

Approval of Minutes

McDermid motioned to approve the minutes, Jackson seconded. The motion carried by a voice vote.

1 <u>22-0065</u> REACH Introduction - Loretta LaPoint

LaPoint was unable to attend, so staff will schedule a time to visit.

2 22-0054 Planning for Town Hall w/ Elected Officials

McDermid suggested hosting an event, possibly a panel, on how to handle racism in the workplace (from employees and customers). Jackson said it is important to consider the culture of your business you want to consistently convey. Turner liked the idea of focusing on a specific topic, such as supporting black-owned businesses; HRC could step up out reach in general as well. McDermid suggested the possibility of a series of town halls, like for policing. Hope Restores is doing series of town halls as well. Sargent requested that the Racial Equity Team be invited to these events.

3 22-0056 Discussion on Strategic Planning Process

McDermid shared the strategic planning framework the HRC did with Jason Gilman; it needs measurable goals. McDermid suggests the plan answer how the City can address human rights and racial issues on a regular basis; Madison's Civil Rights Dept. can serve as a model. Turner envisioned that the plan would outline how the HRC can create policy. Staff can include comprehensive plan updates at meetings. Previous workshop was two evening meetings, which could be replicated to create goals.
