Good morning Jay,

Sorry I did not get back to you Friday; I was out of the office.

Your request for permission to apply for a Combination "Class B" beer and liquor license was just introduced; there was no discussion. Items that are introduced are just noted on the agenda and automatically referred for 30 days.

Your request for permission to apply will go to the following meetings in November cycle:

Judiciary & Administration Committee Chambers, 1 st Floor of City Hall	Tuesday, October 31, 2017 at 6:00 p.m. in the Common Council
Common Council (final action) Chambers, 1 st Floor of City Hall	Thursday, November 9, 2017 at 6:00 p.m. in the Common Council

If at the November 9 meeting they grant your permission to apply for an alcohol license, you have 60 days in which to make application. Therefore, you could come in as early as Friday, November 10 but no later than Monday, January 8, 2018 to make application.

When you come in to make application, bring photocopies of the following with you :

- Articles of Incorporation for Pride Hotels, LLC
- Wisconsin Sellers Permit
- Federal Employer Identification Number
- Application Fee (cash or check). The fee will range somewhere between \$370.27 and \$270.06; depending on what month you are in to apply. The fees are prorated and you pay only for the months you have the license.

All members of the LLC and the person serving as agent should be present when making application because there are signatures required; bring identification.

The agent must be a resident of the State of Wisconsin (for the last 90 days) and live within 25 miles of the City of La Crosse.
