Rent

- 1. Rent is due on the first of every month, except where indicated on this lease. All payments are to be mailed to <u>1819 Hyde Avenue</u>, <u>La Crosse</u>, <u>WI</u>, <u>54601</u> if you have any concerns you can Text us at <u>(608)</u> <u>498-7368</u> or Email us at <u>laxrental@gmail.com</u>
- 2. We do all of our communications via text, email or USPS and we will only communicate with the people who are on this lease.
- 3. \$700 for rent is due on August, 24th, 2021.
- 4. <u>\$0</u> for rent is due on the first day of the last month of this lease.

Moving In

- 1. Move in Appointments are scheduled on a first come first serve basis.
- 2. If you plan to leave the apartment empty for more than a month, notify the property manager.
- 3. You have 7 days after you move in to turn in your Move-In Forms. After that, you will be responsible and accountable for anything not reported.
- 4. No cosmetic alterations or cleaning will be done by L&M Apartments after move in.
- 5. In order to move in early all tenants must be present at time of move in & must sign a move in early form.
- 6. Tenant must change the electricity in their name within 7 days of moving in.
- 7. If tenant needs a new copy of a key to their apartment one will be provided for \$20.
- 8. If the key to the laundry room is lost then it will be a $\underline{\$50}$ charge.

Security Deposit Returns

- 1. The deposits are for paying damages, unpaid fees or bills and is not to be used for rent.
- 2. Deposit will be returned within <u>21</u> days after the move out date.
- 3. If all of the security deposit is not returned an itemized statement will explain why.
- 4. If you have not received your deposit within <u>21</u> days after your move out date, please sent us a letter. Security Deposits can be sent via USPS or PayPal.
- 5. Work done to the apartment can cost up to \$35 an hour.
- 6. Make sure that you forward your mail with USPS to your new address; your deposit will be sent to the address of the apartment that this lease is for.
- 7. If there is any amount owed to L&M Apartments, you will all be responsible for paying that amount within 14 days after your deposit has been received.
- 8. If you change, add or remove any locks it will be \$100 per lock.
- 9. If you do not return all of the apartment and laundry room keys, it will be a cost of \$90 per lock.
- 10. Any items left behind will be disposed of at tenants cost.
- 11. Each tenant will receive a return and the check or bill will be divided equally.
