That part of alley right of way adjacent to Lots 4, 5, 6, 7 and 9 of Block 2 of the First Addition to Spliers Addition located in the SW 1/4 of the SW 1/4 of Section 33, Township 16 North, Range 7 West, City of La Crosse, La Crosse County, Wisconsin being more particularly described as follows:
Beginning at the Southwest corner of Lot 9 of said Block 2 being located on the North right of way line of Vine Street; thence West along the North right of way line of Vine Street to the intersection of the South line of Lot 7 and the Northwest right of way line of said Alley in Block 2; thence Northeasterly along the Northwest Alley right of way also

being the South lines of Lot 7, Lot 6, Lot 5 and Lot 4 to the Southeast corner of said Lot 4; thence Southeasterly 20 feet more or less along the prolonged East line of said Lot 4 to a point on the Northwesterly line of Lot 9; thence Southwesterly along the Northwesterly line of Lot 9 also being the Southeast Alley right of way line to the point of beginning.
