Subject: Annual Citywide Traffic Signal Replacement Program

The Engineering Department has prepared a program request for annual replacement of City Traffic Signals in the CIP budget. The City of La Crosse currently owns and maintains traffic signals at 60 intersections. These assets comprise approximately \$21,000,000 of public infrastructure. This program replaces, updates, and modernizes approximately 2 traffic signals per year, as part of a 30-year replacement plan. The requested annual allotment, which accounts for future inflation, is \$1,000,000. This budget can be adjusted year to year if needed, based upon industry standards, State Grants, and signal needs.

The initial signal replacements that we have identified are locations where we have the oldest signals (16th & Main Street, Rose & St. James St) or locations where we need to modernize the equipment (2nd & State St). Future signal replacements are based on State planned project locations, age of the signal equipment, or need for modernized equipment. Replacements will include poles, lights, bases, conduit, wiring, signs, cameras, and other appurtenances. All signals cabinets and controllers are already in the process of replacement.

It is the intent that this program be continually renewed annually to assist with upgrading and replacing Traffic Signals within the City of La Crosse to reduce maintenance needs for these aging traffic signals.
