(3) (2) One (1) resident or non-resident La Crosse County Board Supervisor, who shall be appointed by the Mayor and confirmed by the Council for a term of two years or until the end of an elected term on the Count Board whichever is acc. the County Board, whichever is earlier

(4) (3) An One (1) unpaid stu-dent representative from each one of the City's three institutions of higher education, which currently consist of three institutions, said stu-dent representatives shall serve for dent representatives shall serve for a terms of one year each beginning on June October 1 of each year. The Mayor shall appoint the student representative on a rotating basis from each of the three institutions of higher education subject to confir-mation by the Council. The student government of each institution shall submit its recommendation of a sin-gle candidate for appointment, if any, to the City, no later than May 1 me th
