To whom it may concern,

In January of 2024 we purchased a home at 3828 33<sup>rd</sup> Street South. We had previously lived in the Town of Greenfield in La Crosse County. When we purchased this home, we had adopted five children (all victims of childhood trauma, including neglect, physical, mental and sexual abuse). At the time of the purchase we had only a 13 year old girl living with us.

She came into our home when she was four years old. She was a trauma victim. It took several years for her to get to a point where she was comfortable being in a room alone. She still is extremely anxious when alone or in large crowds.

When we moved in, she was extremely anxious and was very worried about people moving through our yard.

We have been in contact with Phillips Outdoor Services about putting a fence around our back yard. We want a gate onto the walking trail adjacent to Pammel Creek (that we can secure from inside the yard).

We have had the property surveyed, and see the right of way in question. We are asking for a variance to build a fence that meets the fence at two points and will run perpendicular to that fence. We understand that we would be responsible for removal of the fence in the event of need to address issues within the right of way, as well as reconstruction costs. Additionally in an emergency we will assist in any way to ensure access if needed, and will be responsible for costs incurred because of the fence.



BE IT FURTHER RESOLVED that if the adjacent property owners do not wish to purchase the access land at one (\$1.00) then in order to protect the property interest of the City, the new recreational trail fence for the 33<sup>rd</sup> Street Recreational Trail shall be placed on the property line at those points.

BE IT FURTHER RESOLVED that there is hereby appropriated up to the sum of Eight Thousand Five Hundred dollars (\$8,500.00) from the contingency fund in order to provide for any additional title or survey work.

In accordance with the Council resolutions adopted, please sign the bottom of this letter and return it to the City of La Crosse if you are willing to accept the portion of land adjacent to your residence. The City will record the quit claim deed and transfer the property. Also, in accordance with the Council resolutions, the fence will be placed on the property line. If a property owner elects not to accept the City land, then the fence will not be placed 25' from the Pammel Creek wall but will be placed on the existing property line you currently occupy. The City will retain a 7' easement for maintenance and reconstruction of Pammel Creek flood improvements on the east side of the fence in which the property owner will be responsible to maintain this area.

### FENCE PERMIT

### Do I need a building permit?

Yes.

### **Data Requirements:**

- Completed and signed Application for Building Permit.
- One (1) set of "to scale" plans: plans may be submitted electronically if you wish. A set includes a top or "plan view" looking down on your project showing placement of the fence with measurements to property lines and a side or "cutaway" view showing your proposed method of construction, size and placement of posts, height of the fence and type of fence.
- A copy of the manufacturer's specifications (if required).
- Additional information may be required if fence is within three feet of a lot line, see answer below for more information.

### How much does a permit cost?

Building Permit Fees can be found on the City website at this link: https://www.cityoflacrosse.org/fire/fees/buildings.

### How long does it take to get my permit?

Permits are reviewed on a first come, first serve basis. Inspectors are allowed 10 business days to complete. They may take longer depending on circumstances. For an additional cost you can EXPEDITE your application, moving it to the forefront.

### How close to my lot line can I build my fence?

Per City of La Crosse Municipal Code of Ordinances 115-398(c). Height and setback of fences regulated:

- (1) Residential fences are permitted up to the property lines in Residential Districts but shall not, in any case, exceed a height of six feet without a conditional use permit, shall not exceed 48 inches in height from grade in the front, side, or rear yard setback abutting a public sidewalk, shall not encroach into any vision corner and shall not be closer than three feet to any public right-of-way along a public alley. The height of any fence shall be measured as an average and shall not include the posts or pillars to which a fence is attached.
- (4) In the case of a proposed fence installation within three feet of a lot line where no record of a fence existed, a survey prepared by a registered land surveyor or professional engineer is required to obtain a building permit. No survey is required if a recordable affidavit signed by all affected property owners establishes an agreed upon lot line. No permit shall be issued for a fence three feet or closer to a lot line until the adjacent property owners have been notified in writing by the Department of Community Risk Management and 15 days have passed. If a recordable affidavit is provided, the 15 day period can be waived.

### Do I need concrete footings under my fence?

Per code, you do not. The fence must be installed to the manufacturer's specifications.

### When must I call for building inspections?

Inspections are required:

- If a footing is required and the holes are ready for viewing <u>before</u> posts are installed
- When the project is complete

### Frequently encountered issues:

Following is a list of frequent problems or errors we encounter:

No pier depth inspection

The property owner is responsible for correct placement of structures upon a parcel of land to comply with the building and zoning law. The back edge of the City sidewalk is usually located on a property line.
