ORDINANCE NO.: 4800
 AN ORDINANCE to annex a parcel of land from the Town of Campbell to the City of La Crosse (Binsfeld Property)
 THE COMMON COUNCIL of the City of La Crosse do ordain as follows:
 SECTION I: Proper petition having been presented to the Common Council of the City of La Crosse praying for annexation of the following territory, to-wit:
 SEE ATTACHED EXHIBIT "A"
 to the City of La Crosse, Wisconsin, it is hereby ordained that the above described property be, and the same is hereby annexed to the City of La Crosse, Wisconsin from the Town of Campbell, La Crosse County, Wisconsin, and it is further ordered that Sec. 1.01 of the Code of Ordinances of the City of La Crosse entitled "City Boundaries" is hereby amended to include the above described property within the corporate limits of the City of La Crosse, Wisconsin.
 SECTION II: Section 1.02 of the Code of Ordinances of the City of La Crosse entitled "Aldermanic Districts - Boundaries" is hereby amended where required to include the above described property within the First Aldermanic District. The County Board of Supervisors for La Crosse County is further requested to have the annexed area included in the same district and ward for the County Supervisor's seat as for the City Council Member.
 SECTION III: This Ordinance shall take effect upon its enactment.

 Part of Government Lot 3, Section 18, T18N-R10E, Range 10 East, County of Dade, State of Wisconsin, more or less as shown.
 Commencing at the southeast corner of Lot 35, (7th Addition to the City of La Crosse) and the east-southwest corner of the said Lot 35, (7th Addition to the City of La Crosse), and running north 89° 52' 21" W 42.43 feet to the point of beginning of the subdivision;
 Thence, south 89° 52' 21" W 220.00 feet to the center of the street;
 Thence, along the center line, N 23° 31' 17" E 28.72 feet;
 Thence, S 86° 02' 21" W 143.10 feet to the point of beginning of the subdivision.
 Including all lands (dry) between the municipal line and the water table.
 Subject to any easements, encumbrances and restrictions of record.
