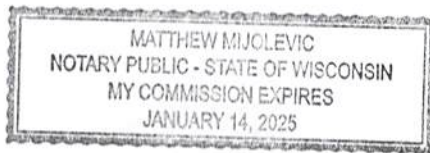

TO WHOM IT MAY CONCERN:

NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse, by its Judiciary & Administration Committee, will hold a public hearing on a proposed ordinance change in the zoning code as follows:

AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse by transferring certain property from the Commercial and Residence Districts to the Traditional Neighborhood Development District - General allowing for apartments, green space, and off-street parking at 620 and 626 Cass Street, 308, 316, 318, and 322 7th St. S.

Property is presently: dry cleaning business and two vacant residential houses.

Property is proposed to be used as: apartments, green space, and off-street parking.

Rezoning is necessary: because site specific apartment design that includes departures from existing standards, including reduced vehicular parking, reduced site setbacks, and street-facing bioretention areas.
