Carolyn Dvorak suggested an event to educate the public on safe riding in a roundabout; Chuck Lee agreed. Gallager commented that large turning radii make pedestrian crossings at West Ave. difficult; that traffic light timing hasn't changed on West Ave. since lights were installed; and that he was surprised that Badger had relatively few crashes. Loehr asked about the ages of the crashes; Eastwood said age of fatalities ranged from 17-74 (5 of 6 were under 55), and not disproportionate number of crashes with kids.
