AN ORDINANCE to amend Section 115-110 of the Code of Ordinances of the City of La Crosse by transferring certain property from the Public and Semi-Public District to the Planned Development District - General at 1401-1403, 1407, 1409-1411-1413, 1415-1417, 1423 7th St S., 710 Farnam and 711 Tyler Streets allowing for medical resident housing.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

710 Farnam St. 17-30078-110 - E 50FT OF N 25FT LOT 9 & E 53FT LOT 10 BLOCK 2  
711 Tyler St. 17-30078-60 - E 60FT LOT 6 BLOCK 2  
SECTION II: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.  
SECTION III: This ordinance shall take effect and be in force from and after its passage and publication.


