BE IT FURTHER RESOLVED that the Director of Finance, Director of Human Resources and Director of Parks and Recreation are hereby authorized to implement this resolution.

Seasonal Gardener

The purpose of the position is to select and provide care for appropriate plants to maintain professional landscaping on city properties. Duties include working with local nurseries to obtain appropriate plants, weeding, mulching, pest identification and watering, and directing seasonal staff to complete landscaping duties at parks and gardens.

Position requirements:

- Valid driver's license
- 2 seasons of paid employment in a gardening position or Associate degree in Horticulture.
- Knowledge of plant species, plant care, weed and pest identification, pruning and trimming.

Seasonal Tree Trimmer

The purpose of the position is to safely perform tree trimming, cutting and planting. Requires working outdoors in adverse weather conditions.

Position requirements:

- Valid driver's license
- 2 or more years of experience using a chainsaw
- Experience working with a chipper machine
- Working knowledge of tree trimming procedures and tree identification

Aquatic Maintenance Worker

The purpose of the position is to monitor and test pool chemicals to ensure proper levels. Monitors the operations of mechanical components and maintenance procedures for aquatic mechanical systems to ensure proper operations.

Position requirements:

- Valid driver's license
- Aquatic Facility Operator (AFO) certification or Certified Pool Operator (CPO) certification required.
- Extensive knowledge in aquatic facility maintenance
