Resolution authorizing the Neighborhood Revitalization Committee to solicit, accept and expend voluntary contributions.

## RESOLUTION

**WHEREAS**, the Common Council of the City of La Crosse previously adopted policy guidelines for the solicitation, acceptance and expenditure of voluntary contributions to the City of La Crosse in Resolution File #2003-03-032; and

**WHEREAS**, the Neighborhood Revitalization Committee has requested to amend such policy guidelines to enable it to solicit, accept, and expend voluntary contributions made to the Committee consistent with its purpose and for the benefit of the City of La Crosse.

NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LA CROSSE that it hereby authorizes the Neighborhood Revitalization Committee to solicit, accept, and expend voluntary contributions made to the Neighborhood Revitalization Committee consistent with the provisions of this Resolution and the purposes and function of the Neighborhood Revitalization Committee as set forth in the applicable City ordinances and resolutions.

**BE IT FURTHER RESOLVED** that the Neighborhood Revitalization Committee may, upon approval by the Neighborhood Revitalization Committee, solicit and/or accept voluntary contributions, including monetary and real property, in an amount or value not greater than \$100.00 from a single donor.

**BE IT FURTHER RESOLVED** that the Neighborhood Revitalization Committee is not authorized to accept contributions which will cause the City of La Crosse to incur additional expense, except as otherwise approved by the Common Council.

**BE IT FURTHER RESOLVED** that the Neighborhood Revitalization Committee may, upon approval by the Neighborhood Revitalization Committee, expend voluntary contributions that it has received provided such expenditure is consistent with the intent of the contribution.

**BE IT FURTHER RESOLVED** that any and all solicitation, acceptance, and expenditure of contributions as set forth in this Resolution shall be in compliance with local, state, and federal law.

**BE IT FURTHER RESOLVED** that the Finance Director may establish an account for any contributions to the Neighborhood Revitalization Committee, and may determine policies and procedures for the account, including but not limited to, the accounting, deposit, and expenditure of funds, which must be adhered to by the Neighborhood Revitalization Committee.

**BE IT FURTHER RESOLVED** that this Resolution amends and supersedes Resolution File #2003-03-032 only as applicable to the Neighborhood Revitalization Committee, and any provisions of Resolution File #2003-03-032 not in conflict with this Resolution remain in full force and effect; .

**BE IT FURTHER RESOLVED** that the Finance Director and Neighborhood Revitalization Committee are hereby authorized to take any and all steps necessary to implement this resolution.
