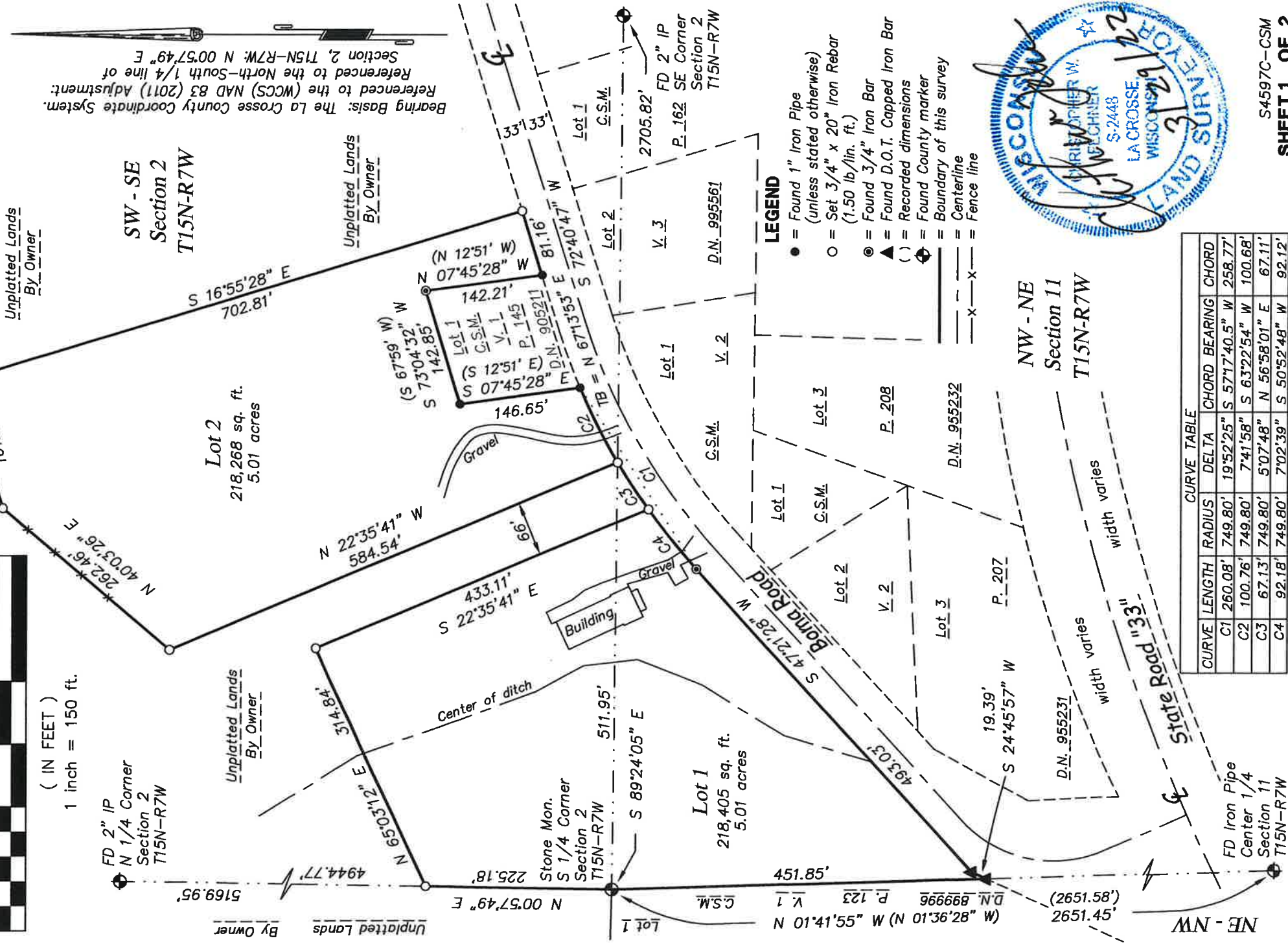

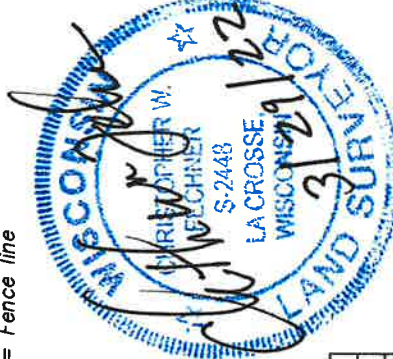

**SURVEYOR'S CERTIFICATE**

I, Christopher W. Fechner, Professional Land Surveyor, do hereby certify that I have surveyed and mapped this Certified Survey Map being part of the SW 1/4 of the SE 1/4, Section 2, NW 1/4 of the NE 1/4, Section 11; all in T15N-R7W, Town of Shelby, La Crosse County, Wisconsin described as follows:

Beginning at the South 1/4 corner of Section 2, thence, along the West line of the SW 1/4 of the SE 1/4, N 00°57'49" E 225.18 feet;  
thence N 65°03'12" E 314.84 feet;  
thence S 22°35'41" E 433.11 feet to the northerly right-of-way line of Boma Road;  
thence, along said northerly right-of-way line, on the arc of a 749.80 foot radius curve, concave to the southeast, the chord of which bears, N 56°58'01" E 67.11 feet;  
thence N 22°35'41" W 584.54 feet;  
thence N 40°03'26" E 262.46 feet;  
thence N 73°04'32" E 161.64 feet;  
thence S 16°55'28" E 702.81 feet to said northerly right-of-way line;  
thence, along said northerly right-of-way line, S 72°40'47" W 81.16 feet to the southeast corner of Lot 1, Certified Survey Map, Volume 1, Page 145, Document Number 905211;  
thence N 07°45'28" W 142.21 feet to the northeast corner of said Lot 1;  
thence S 73°04'32" W 142.85 feet to the northwest corner of said Lot 1;  
thence S 07°45'28" E 146.65 feet to the southwest corner of said Lot 1 and said northerly right-of-way line;  
thence, along said northerly right-of-way line, on the arc of a 749.80 foot radius curve, concave to the southeast, the chord of which bears, S 57°17'40.5" W 258.77 feet;  
thence, continuing along said northerly right-of-way line, S 47°21'28" W 493.03 feet;  
thence, continuing along said northerly right-of-way line, S 24°45'57" W 19.39 feet to the West line of the NW 1/4 of the NE 1/4;  
thence, along said West line, N 01°41'55" W 451.85 feet to the point of beginning of this description.

Subject to any easements, covenants and restrictions of record.

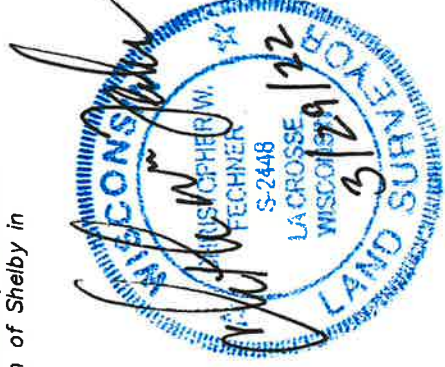
