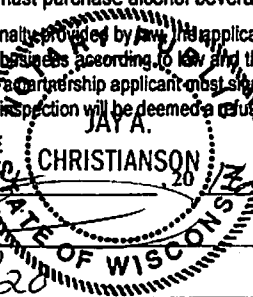

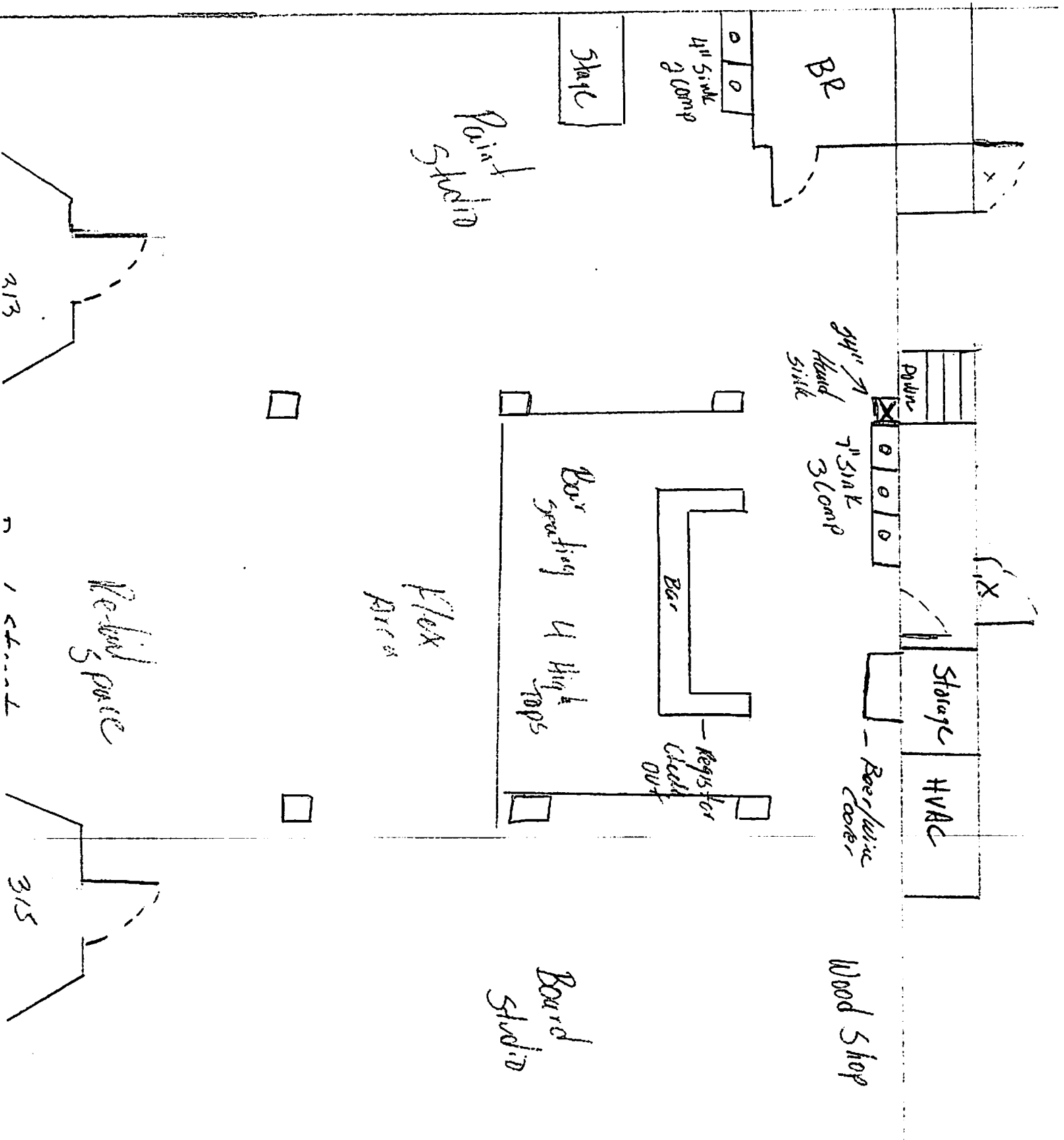

RE: Class "B" Beer and Liquor License – Generous Earth Pottery LLC

Due to a long time planned trip abroad we are unable to attend the Common Council meeting on October 13, 2016, where you shall vote on our application. We currently hold a Class "B" Beer and Liquor License for our business Creative Canvas, located at 309 Pearl Street La Crosse, WI granted by the Common Council October 2016. Due to our business growth and expansion we are required to apply for a new license for our new location at 313 Pearl Street La Crosse, WI. If approved we shall surrender our current license. We plan to operate our business in the same fashion as we currently do, offering beer and wine as more of an amenity to our guests than as a source of revenue. To date our revenue from the sale of alcoholic beverages has not exceeded 3 % of our gross revenue.
