

COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 35; THENCE NORTH 78'58'43" WEST 1174.14 FEET TO THE NORTHERLY RIGHT OF WAY OF COUNTY ROAD F AND THE POINT OF BEGINNING; THENCE CONTINUING ALONG SAID NORTHERLY RIGHT OF WAY ON THE ARC OF A 853.35 FOOT RADIUS CURVE, CONCAVE SOUTHWEST, THE CHORD OF WHICH BEARS NORTH 56'58'24" WEST AND MEASURES 63.34 FEET, NORTH 30'54'00" EAST 7.00 FEET, AND NORTH 59'06'00" WEST 63.72 FEET; THENCE NORTH 23'42'09" EAST 122.90 FEET; THENCE NORTH 28'46'54" EAST 55.68 FEET; THENCE SOUTH 66'42'04" EAST 48.06 FEET TO THE P.C. OF A 100.00 FOOT RADIUS CURVE; THENCE ALONG THE ARC OF SAID CURVE, CONCAVE SOUTHWEST, THE CHORD OF WHICH BEARS SOUTH 53'37'29.5" EAST AND MEASURES 45.25 FEET TO THE P.C.C. OF A 450.00 FOOT RADIUS CURVE; THENCE ALONG THE ARC OF SAID CURVE, CONCAVE NORTHEAST, THE CHORD OF WHICH BEARS SOUTH 43'20'55.5" EAST AND MEASURES 43.97 FEET; THENCE SOUTH 27'50'21" WEST 177.29 FEET TO NORTHERLY RIGHT OF WAY OF COUNTY ROAD "F" AND THE POINT OF BEGINNING.
